EcoPartnership Application – 2017

The Joint Secretariat of EcoPartnerships, co-chaired by the Department of State of the United States and the National Development and Reform Commission of the People's Republic of China and hosted under the Ten-Year Framework for Cooperation on Energy and Environment (TYF), invites new applications for establishing EcoPartnerships between subnational entities in the United States and China.

The EcoPartnerships program is a platform under the TYF to foster practical cooperation between the United States and China. It spurs innovation, investment, and progress toward shared goals in both countries through voluntary partnerships between subnational governments, companies, non-governmental organizations and research institutes. To date, more than 40 partnerships have been launched, with good outcomes resulting from the joint research and demonstrations of innovative technologies and concepts, realizing synergies among policies, R&D, markets and financing. EcoPartnerships continue to explore new models for sustainable development in the United States and China.

Applicants should be highly motivated, and technically and administratively capable of executing actionable and innovative projects, relevant to the Ten-Year Framework for Cooperation on Energy and Environment or the U.S.-China Climate Change Working Group (CCWG) between the Government of the United States of America and the Government of the People's Republic of China, through technical cooperation, demonstration, and/or information exchanges. New EcoPartnerships must sufficiently demonstrate both programmatic competence and financial capacity to successfully implement the intended activities.

Applicants must complete their proposals in **both** English and Chinese and **simultaneously submit both versions** to the U.S. Secretariat at solicitation@lbl.gov **and** to the Chinese Secretariat at ecopartner@163.com by the deadline listed. Application deadline:

Applications not submitted **in both languages** to both email addresses by the deadline will be disqualified as incomplete, and will not be considered. The English and Chinese versions of the applications should be identical in content to the extent possible.

Clearly address each section of the application. The Advisory Committee that selects new EcoPartnerships uses this information as the basis for its decision. The evaluation criteria are listed on the program <u>website</u>. The solicitation is highly competitive every year, yielding a wide variety of proposals from well-qualified organizations. Therefore, applicants that offer vague responses will be at a disadvantage relative to peers that deliver a thorough, compelling, and viable application.

Applicants should clearly describe the project purpose and anticipated results within the three year period of the EcoPartnership, focusing on the applicants' innovative approach, capabilities and the expected impact that the project will generate. In addition, applicants should have sufficient resources to conduct the project prior to submitting a proposal. If additional fundraising is needed to underwrite any of the key tasks, it is highly recommended that the parties wait to apply to the next solicitation once funds have been secured.

This application should be made in good faith, with the intent to follow-through on the stated activities to the extent practicable. If a proposed EcoPartnership is selected to join the program, the participating organizations will sign a Statement of Intent. It is not a contract, nor is it legally binding, but serves as a public opportunity to signal the intent of all participants to voluntarily work together on the project. This collaboration may be terminated at any time based on the needs of either party in the EcoPartnership, with care taken to provide advanced, written notice as early as possible. The EcoPartnership may also be dismissed from the program if no substantive progress is achieved or if there is a significant deviation from the pilot project proposed in the application.

All sections must be completed. Relevant supporting materials (such as documents, certificates, charts or pictures) can be submitted as appendix material with the application. The example text that follows may be deleted to allow full use of the space.
